## NIOSH/CDC News

### Mast Climbing Inspection Tool

The National Institute of Occupational Safety and Health (NIOSH) created an [inspection tool for mast climbers](#). The walkthrough program shows common inspection points on this equipment and what to look for in each area.

## OSHA News

### Rise in At-Work Suicides

The rate of suicide at work increased by 11% in 2018. The Occupational Safety and Health Administration (OSHA) created a new [Preventing Suicide](#) webpage with links to suicide prevention phone numbers and online chat. The page has poster graphics for these services and links to other assistance websites.

### Regulatory Error Correction

OSHA published a notice in the [December 17, 2019 Federal Register](#) to correct errors and clarify requirements in the Walking-Working Surfaces and Personal Protective Equipment standards. The corrections clarify height of ladder side rails, exclusion of coverage for articulated stairs, proof testing of snaphooks, carabiners, and D-rings, and several typographical errors.

### Headphone Use on Construction Sites

A recent [letter of interpretation](#) from OSHA regarding Standard 1926.52 and 1926.101 confirms that there are no OSHA regulations that prohibit the use of headphones on a construction site but cautions that struck-by hazards are one of the four leading causes of death at construction sites and listening to music can cover up sounds that alert workers to danger.

## Other News

### Material Handling Injury Prevention

The Center for Construction Research and Training (CPWR) recently added resources to the [Best Built Plans \(BBP\)](#) program. CPWR designed the program to reduce the risks for soft tissue injuries from manual material handling by providing contractors with resources at each project stage to use on the job to raise awareness and reinforce safe practices. New items include an app version of the planning and interactive training resources, a Spanish version of the planning tool, and a video on how to use the program.

## Risks for Vaping Product Associated Lung Injuries

---

The Centers for Disease Control and Prevention (CDC) reported on a public survey from the Illinois Department of Public Health (IDPH) in their [Morbidity and Mortality Weekly Report](#). IDPH conducted an online public survey during September–October 2019 targeting e-cigarette or vaping product users in Illinois. The CDC said: “The findings in this report reinforce current recommendations that persons should not use e-cigarette, or vaping, products that contain THC, or any e-cigarette, or vaping, products obtained from informal sources such as off the street, from a dealer, or from a friend. In addition, because the specific compound or ingredient causing lung injury is not yet known, the CDC continues to recommend that persons consider refraining from use of all e-cigarette or vaping products while the outbreak investigation continues.”

## Work Zone Safety

---

CPWR has a set of resources to prevent struck-by injuries in construction work zones. Struck-by hazards are a leading cause of fatal and nonfatal injuries in construction. This [webpage](#) contains material from a variety of sources and includes fatality reports and videos from NIOSH, OSHA resources, toolbox talks, handouts, and links to research.
